RECOMMENDATION

Approve resolution file application with the California Governor's Office of Emergency Services (CalOES) for the purposed of obtaining federal financial assistance for any existing or future grant program as listed.

SUMMARY

In 2023, HCRCD requested FEMA and CalOES Public Assistance Disaster Funding to remove sediment from the Francis Creek Sediment Management Area as part of the Salt River Ecosystem Restoration Project that accumulated during two federal emergency declaration periods. FEMA has obligated (i.e. secured) funds (HCRCD project #174). HCRCD has provided all documents to FEMA and is awaiting final processing through CalOES.

2023 construction activities at the SMA are complete. Approximately 14,000 cubic yards of sediment was excavated.

FISCAL IMPACT

Action is required to receive state cost share and contracting of funds. No action will result in a fiscal impact to the General Fund of \$466,052.80. Action will result in the final obligation of \$436,924.50 of funds to be provided to fund #74 at
