7.2. Resolution No. 25-18 Approving Addendum to the Environmental Impact Report Previously Certified for the Russ Creek and Centerville Slough Restoration Project Director Lane Russ recused himself due to a conflict of interest and left the meeting. Watershed Program Manager Doreen Hansen presented on the proposed changes to the Russ Creek and Centerville Slough Restoration Project Project description to include a modified setback berm alignment, Cutoff Slough Tide Gate design update, additional barn/structure removal and an expansion Project footprint to the south into APN 100-143-012 and APN 101-102-006 to expand tidal restoration by ~50 acres. Executive Director Demers described the analysis to determine whether and to what extent the previous EIR remains sufficient to address the potential impacts of the proposed Project modifications. The conclusion of the analysis is that substantial evidence supports the conclusion that an addendum to the previously adopted EIR is the appropriate environmental review document. All previously adopted mitigation measures in the EIR apply and will continue to apply to the proposed Project modifications under EIR Addendum. Motion to approve Resolution 25-18 and the findings that there will be no significant environmental effects resulting from the proposed Project modifications, provided that mitigation measures identified in the certified EIR are incorporated into the Project by Director Cahill, Seconded by Director Cohoon. - Contract #184-12 with Biswell Forestry, LLC for \$456,245.00 for the Willow Creek Shaded Fuel Break Phase 2 - Manual Fuels Reduction Services.

SUMMARY

HCRCD is administering the USFS Community Wildfire Defense Grant to support wildfire resilience in the Greater Willow Creek Area. HCRCD recently released a Request for Proposals ("RFP") for the Willow Creek Shaded Fuel Break Phase 2 - Manual Fuels Reduction Services to identify an experienced and qualified contractor to perform manual fuels reduction services in the project areas. The RFP was released on Monday, September 15, 2025 and the contractors' Proposals were due Wednesday, October 1, 2025. The HCRCD received Proposals from 9 contractors. HCRCD's Procurement Policy for Federal Awards and Federal Contract Code establishes HCRCD's requirements for subawards and the procurement of services and materials and supplies. In the case of this RFP, contractors' Proposals were ranked by HCRCD based on pre-established criteria, including budget, demonstrated experience and competence, and reference referrals. Using these criteria, HCRCD selected Biswell Forestry, LLC based on budget, level of experience and competence, and reference referrals. The proposal was for \$456,245.00.
